

Notice of Confirmation of Modification Order
Section 53 Wildlife and Countryside Act 1981
The Definitive Map and Statement for the Trowbridge Urban District Council
Area Dated 1953
The Wiltshire Council Trowbridge Path no.8 Definitive Map and Statement
Modification Order 2021

On 5 March 2025, the Secretary of State for Environment, Food and Rural Affairs confirmed with modifications the above Order made under Section 53 of the Wildlife and Countryside Act 1981.

The above Order made on 19 January 2021 modifies the definitive map and statement for the area by upgrading to a bridleway the public right of way, (Path no.8 Trowbridge, Church Lane), leading from its junction with Frome Road at OS Grid Reference ST 8427-5629, in a generally north-westerly direction for approximately 294 metres to its junction with Path no.9 Trowbridge at Acorn Meadow at OS Grid Reference ST 8407-5648, and varying the particulars relating to Path no.8 Trowbridge by providing a recorded width varying between 7 metres and 13 metres, as shown on the Order Map as modified. The Order is confirmed subject to the following modifications:

- Delete *'in green'* from the first line of the description in Part I of the Order Schedule.
- Delete *'in green'* from the fifth line of the description in Part I of the Order Schedule.
- Delete the sixth and seventh lines from the description in Part I of the Order Schedule.
- Replace *'4m'* in the seventh line of the description in Part II of the Order Schedule with *'7m'*.
- Add at the end of the description in Part II of the Order Schedule:
'Limitations
The Wiltshire Council may permit posts or bollards to be erected between points X and Y on the Order Map for the purpose of restricting use by unauthorised mechanically propelled vehicles'.
- Include the remainder of Church Lane within the Order Map and add points X and Y at the appropriate points.
- Modify the key to the Order Map to reflect the extent of the route.

A copy of the Order and the Order Map may be seen free of charge at Definitive Map and Highway Records, Wiltshire Council, County Hall, Bythesea Road, Trowbridge, Wiltshire, BA14 8JN from 9:00am to 5:00pm on Monday to Friday by appointment. Copies of the Order may be bought there at the price of £5. The Order becomes operative as from 5 March 2025, but if any person aggrieved by the Order desires to question the validity on the ground that it is not within the powers of Section 53 or that any requirements of Schedule 15 of the Wildlife and Countryside Act 1981 have not been complied with in relation to the Order, he or she may within 42 days from 21 March 2025 make an application under paragraph 12(1) of Schedule 15 of the 1981 Act, to the High Court.
